A RESOLUTION OF THE BOARD OF COMMISSIONERS OF KING COUNTY WATER DISTRICT NO. 125, KING COUNTY, WASHINGTON, REVISING METER INSTALLATION CHARGES.

WHEREAS, King County Water District No. 125 ("District") charges property owners seeking to connect real property to the District's water system a water meter installation charge to recover the cost of materials, paving, labor, equipment, permitting and administration incurred ("Installation Costs") to process such requests and install such water meters; and

WHEREAS, the District is authorized to recover such costs pursuant to Chapter 57.08 RCW; and

WHEREAS, the District now desires to revise and increase its water meter installation charges to recover its costs to provide such service and to account for different costs incurred relating to different meter sizes and the jurisdiction in which the meter is installed; and

WHEREAS, Penhallegon and Associates Consulting Engineers ("PACE") has reviewed the District's existing water meter installation charges and has recommended the revision of such charges based on meter size and the jurisdiction in which the meter is installed as set forth in a report to the District dated December 8, 2003; now, therefore,

BE IT RESOLVED by the Board of Commissioners of the King County Water District No. 125, King County, Washington, as follows:

Water Meter Installation Charges:

The following water meter installation charges shall be paid to the District by parties seeking to connect real property to the District's water system based on customer meter size and the jurisdiction in which the meter is installed as follows:

A. Water Meters installed in the City of Tukwila:

5/8"x3/4" \$1,140.00 1" \$1,240.00

B. Water Meters installed in the Cities of SeaTac and Burien, and in King County:

5/8"x3/4" \$965.00 1" \$1,065.00

C. Meters Larger than One (1) Inch located in any Jurisdiction:

The charge for the installation of water meters larger than one (1) inch in any jurisdiction shall be determined on a case by case basis based on the actual Installation Costs incurred by the District plus fifteen (15) per cent overhead.

2. Effective Date. The revised water meter installation charges set forth in this resolution shall be effective and imposed as of February 1, 2004.

Amendment. That portion of District Resolution No. 02-12-12-349 Section

 (A) "Complete Water Meter Installation Charges" as well as all other applicable District resolutions, policies and procedures are hereby modified, amended and superceded to be in accordance with the provisions of this resolution.
